Personal Data Collection

We may collect, store and use the following kinds of personal information:

- (g) Information that you post to our website for publication on the internet including your user name, your profile pictures and the content of your posts.
- (h) Information contained in or relating to any communications that you send to us or send through our website including the communication content and Meta data associated with the communication.

Usage of personal Information

Personal information submitted to us through our website will be used for the purposes specified in this policy on the relevant pages of the website.

- (a) Enable your use of the services available on our website

Disclosing personal information

Except as provided in this policy, we will not provide your personal information to third parties.

We may disclose your personal information:

- (a) To the extent that we are required to do so by law;
- (b) In connection with any ongoing or prospective legal proceedings;
- (c) In order to establish, exercise or defend our legal rights (including providing information to others for the purposes of fraud prevention and reducing credit risk)
- (e) To any person who we reasonably believe may apply to a court or other competent authority for disclosure of that personal information where, in our reasonable opinion, such court or authority would be reasonably likely to order disclosure of that personal information.

International Data Transfer

Information that we collect may be stored and processed in and transferred between any of the countries in which we operate in order to enable us to use the information in accordance with this policy.

Personal information that you publish on our website or submit for publication on our website may be available, via the internet, around the world. We cannot prevent the use or misuse of such information by others.

Personal Data Protection Policy
